Meeting Minutes

Principal's Report:

- Thank you to PTO for breakfast for staff their first week
- "Donuts with Dance" for staff last week
- 2 great weeks with staff so far
- Hiring
 - o 5 open positions
 - 2 education aides (1 was offered and accepted but there was a mix up at Central Office so we are trying to figure that out)
 - 2 general education teachers (2nd grade math and 4th grade ELA)
 - 1 inclusion teacher for students with specific needs
 - A new first grade teacher has been hired but is waiting on DCPS to on-board her (Ms. Harvey)
 - We have great subs (including Ms. Jenkins) to fill in as needed
- Back to School Night: September 8 at 5;30pm (families will continue to receive robo calls and texts to remind them)
- Concern about crossing guard

Comprehensive School Plan (CSP):

- Principal Dance meeting with Instructional Superintendent and Cluster Friday; will share CPS with staff and then families
- CSP helps monitor goals and progress to ensure we meet EOY goals
- Goals include:
 - o Collaboration (key to include staff in all decisionso
 - Engagement (working with Bijan Verlin and Community Action Team)
 - o Culture of Achievement and Academics (includes SEL)
- Attendance
 - Attendance at end of year was 87.32%--district goal is 95%; DCPS likes improvement of 5-8% so our goal for EOY this year is 92%
 - Projected attendance is 395 for this year; 42 enrolled students who are "unaccounted for" (either have not attended yet or have enrolled elsewhere)
 - Currently at 85.5% of projected goal; expected to be at 95% by end of this week (that's also a district goal but district is currently at 86%)
- Technology
 - o There are MANY devices that are not working that must be officially discarded
 - Still 1:1 in grades 3-5 and 3:1 in grades PK-2
 - Students currently taking BOY testing on these devices
 - o We now have a computer lab that can hold 20-25 students!
 - Teacher devices:
 - Looked at by OCTO; non function devices were replaced
 - 8 additional devices for staff have been delivered this week
 - OCTO will have a rep at school Tuesdays and Thursdays to help with tech needs (can help with all teacher tech needs, not just computers)
 - o Non-computer devices:
 - No update on SmartBoards
 - According to DCPS, we are "due" for upgrades (have been told this for over a year)

Mission/Vision Work:

- Goal is to create a mission and vision with entire community
- Collaboration is key
- No true Mission/Vision in 5+ years
