Open Budget Discussion:

- School Surveys
 - o IS Shawn Stover shared the results of surveys sent to parents and teachers
 - The key priorities were the following:
 - Consistency
 - Culture/SEL
 - Instructional flexibility
 - No parents completed the survey (uncertainty of how it was shared); 6 teachers completed it. Other feedback was considered.

- Feedback before Open Session ends:
 - o Concerns about going into Closed Session
 - Was notice properly given?
 - Was agenda shared 48 hours in advance?
 - IS Stover and CAT Rep Verlin believe that sufficient notice was given but the LSAT opted to have a formal vote (as opposed to consensus) to go into Closed Session.
 - Motion to go into Closed Session was made and seconded
 - Vote: 6 of 9 members present voted to go into Closed Session
 - Concern noted that this may be a violation of the Open Meetings Act (specifically a procedural violation)
