Enrollment Update

- Currently 111.7% enrollment 411 students
- Losing kids during the week but gaining kids the following week
- Different grade levels coming and going- mostly due to moving
- Shout out from Chancellor Ferebee's office to see what we did to increase enrollment –
 Chancelor will be discussing this with Mayor
- Some of the activities that have led to Miner's enrollment success include lots of open houses, enrollment day events, teachers calling homes, competition to re-enroll students returning to Miner
- Projected enrollment was supposed to be 368
- Because we got students after the fact, didn't provide us more funding

FY23/24 Budget Update

- Reprogrammed funding for another second grade teacher have quality candidates for second grade position - can teach social studies and math - can pull out for special groups – great need to fill this position
- Over 50 kids in second grade
- No timeline for filling of the position due to DCPS hiring process outside of school control- but the money is ours
- More money into equipment and machinery ~\$1500
- \$2700 educational supplies
- Funding for two additional aides can be very flexible positions can use as floater, para, office admin two aides
- Added \$10k to custodial and maintenance
- \$5k to custodial overtime
- 5th graders to participate in Nature Bridge program 3 days and two nights overnight science camp in cabins
- Pay for FoodPrints \$20k
- Reading partners students starting to get pulled for reading partners
 - K- 2 and some of the 5th graders

Comprehensive School Plan

- BOY data- BOY assessments completed, moving to progress monitoring
- Monitoring academic assessments, attendance, and teacher insight data
- MOY will do slide deck and presentation at MOY to report on progress
- Working with IS Carruthers on support for attendance, math, ELA

Enrollment Projections

- Don't have enrollment projections yet
- Last year, started at 368 ended year at 386
- Watching numbers this year to see if there is a similar rise

Attendance Update

- 90.23% attendance as a school, last year at this time was 89.23%
- Chronic absenteeism 90% or less in attendance rate 31.17% this year, last year at this time was 35.38%
- Roller skating event will be held on the 27th for students with perfect attendance DPR skate party, scooters, snacks and things for students K- 5
- ECE is not part of the event
- Ms. Dykes asked about ECE attendance and possibly organizing some event to award perfect attendance for ECE as well

FY24/25 budget priorities

- LSAT to send out survey to identify budget priorities
- Focus will be on the subject or content area/s that you would like to see investment in
- Not just new investments, but continued investments as well
- Survey will be for parents, caregivers, teachers, staff, and community members

Construction Update

- New 0-3 program will be completely separate from Miner will be inside Miner but will be run by outside program – Miner funding not tied in anyway to the new 0-3 program
- Some school members are stakeholders in process of selecting provider
- Early childhood provider will not have access to the interior of Miner aside from their small wing, which will be built out in the location of four existing pre-K classrooms with separate entrance/exit into and out of building
- Current capital funding not making any repairs inside current Miner building other than to build out new early childhood provider wing
- Principal Dance recently put in request for capital improvements for Miner's current building but will not be funded as part of this project
- Miner has not had any upgrades since 2003 inside building
- Some fixes with fire alarm system were being addressed through DGS
- Principal Dance met with CM Gray staffer last week
 - Major concern raised was to fix the PA system students and staff cannot hear drills and cannot hear when there are important announcements
